### **1. OVERVIEW**

In October 2019, the City of Lockport adopted their Bicycle Master Plan. The plan's purpose was to serve as a guide for the planning, prioritization, and implementation of biking and pedestrian trails that link the City's recreational spaces, schools, commercial areas and other community destinations.

One of the recommendations included in the master plan was to develop a multi-city bike trail that connects the cities of Lemont, Lockport, Romeoville, and Joliet. Currently the I&M Canal Trail runs north from Joliet through Lockport, and connects to the Centennial Trail in Romeoville at Romeo Road. The Centennial Trail continues north to Lemont and connects to the Veterans Memorial Trail. The connection at Romeo Road is adjacent to CITGO Petroleum Corporation. This section of trail is owned by the Forest Preserve District of Will County and leased to the Village of Romeoville.

The City of Lockport and CITGO engaged the planning team of JSD Professional Services, Inc., in June 2021 to research the feasibility of upgrading and improving this connection. The goal of the I&M - Centennial Trail Bike Path Connection Master Plan is to improve trail connectivity, identification, and safety.

## 2. INVENTORY AND ANALYSIS

The planning process began with a site inventory to review existing conditions, document site features, traffic, and current use patterns; as well as complete a photographic inventory. JSD staff, along with the client, visited the site on July 20, 2021.

The I&M Canal Trail is crushed limestone and ends at Old Romeo Road at the edge of the Romeo Road overpass. The trail continues along Old Romeo Road east towards the CITGO property. This section of trail is poorly marked with limited indication that a bicyclist can eventually connect to the Old Centennial Trail. In addition, Old Romeo Road is heavily traveled by semi-trucks Monday through Saturday, with an average of 200 trucks per day, which creates a precarious position for bicyclists and vehicles.

# **CONCEPT PLAN & PRECEDENT IMAGERY**


### 3. CONCEPT PLAN

A kick-off meeting was conducted in June which included the formation of the Bicycle Advisory Committee. The Committee includes representatives from the Village of Romeoville, Village of Lemont, The Forest Preserve District of Will County, and the City of Lockport.

Based on the goals, objectives and needs defined by previous public facilitation efforts, site analysis and discussion during the kick-off meeting, a conceptual plan was developed to illustrate a defined and enhanced connection from the existing I&M Canal trail head across Old Romeo Road and up to Romeo Road which connects to the Centennial Trail to the west. The conceptual design for the enhanced connection includes:

- Visually separated marked lane (painted with "sharrows")
- Flexible bollards
- Improved directional signage
- Bike repair station
- Seating
- Information kiosk
- Public art
- Parking
- Landscape plantings

The Concept Plan is shown below; followed by precedent imagery. A full size version is contained in the Appendix.

































The Concept Plan was presented to the Bicycle Advisory Committee on August 4, 2021 for review and comment and reviewed with the Village of Romeoville's Public Works Department on October 25, 2021.

The following comments were received and discussed:

- Widen roadway for truck access
- Review head wall and parking layout
- Engage a surveyor to complete an existing conditions survey
- Remove the public art sculpture
- Remove the bollards, add reflectors
- Add option for stained concrete wall
- Add striping in lieu of painted surface east of the headwall
- Show future connection to the Romeoville Metra Station

### 4. MASTER PLAN

Based on comments received from the committee, the Concept Plan was revised and the Final Maser Plan was completed. The Master Plan includes updated multi-use trail painted surface limits, widened roadway per truck turn analysis, relocated parking area to accommodate multi-use trail connection to the Village of Romeoville Metra Station, and reduced landscape plantings. A full size version is contained in the Appendix. As part of the Master Plan effort three-dimensional models were generated to illustrate the improvements as defined by the Master Plan. The graphic renderings and precedent imagery are meant to be suggestive in nature relative to the Master Plan layout.

Other funding sources include possible support through programs such as the Transportation Alternatives Program (TAP-L) (Agency: CMAP), the Illinois Bicycle Path Grant Program (Agency: IDNR), Recreational Trails Program (Agency: IDNR) and the PeopleForBikes Community Grant Program (Agency: PeopleForBikes).
